Auditing Related Employers

When auditing related employers, you will now be asked to also submit Appendix H2 with your completed audit. This will verify to the reviewer that audit sampling is representative of the overall operations being audited, and that all the relevant WCB accounts and industry code(s) have been included in the scope of the audit.

This will also provide clarification in the interviews in cases where one company included in the audit is federal and the other is provincial.

Joint Health & Safety Committee Representative Selection

Supervisor: A person who has charge of a work site or authority over a worker. Supervisor is a function, not necessarily a job or job title.

A supervisor could be a representative provided that they do not exercise managerial duties, i.e. hire and fire.

Representative selection FEDERAL

From Section 136 Appointment of Health and Safety Representative:

(2) The health and safety representative for a work place shall be selected as follows:

- (a) the employees at the work place who do not exercise managerial functions shall select from among those employees the person to be appointed; or
- (b) if those employees are represented by a trade union, the trade union shall select the person to be appointed, in consultation with any employees who are not so represented, and subject to any regulations made under subsection (11).

Representative selection PROVINCIAL

OHS Act Part 2

14(1) For the purposes of ensuring cooperation between the employer and workers in respect to health and safety, an employer shall, after consultation with any union that is certified bargaining or has a acquired bargaining rights on behalf of the employer's workers, designate a worker, who is not associated with the management of the employer, as the health & safety representative

COR Certificates Now Paperless-Effective February 28, 2022

Employers now have access to a PDF file of their Certificate of Recognition (COR)!

Employers can access and print their own certificate through their myWCB account with the Workers' Compensation Board - Alberta. This is the same location where you can print your Partnerships in Injury Reduction reports. To download or print your COR certificate, just log into your myWCB account and click on Reports and Invoices.
